establishing a fee schedule
for the Clallam County Planning Department, repealing
prior fees and adopting a chapter in the Clallam County Code (C.C.C.)

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

C.C.C. 3.20.010 Purpose. The public is entitled to efficient and effective administration services provided by the Planning Department. Since County revenue is insufficient to pay for the rising costs of these services, adoption of the fee schedule ordinance is necessary.

C.C.C. 3.20.020 Fee Schedule. The following fee schedule is hereby adopted for administration services provided by the Clallam County Planning Department.

(1) Subdivision Application	\$150 plus \$10/lot
(2) Resubdivision / Replat	\$250 150 <i>JA</i>
(3) Short Plat Application	\$ 50
(4) Short Plat Appeal	\$ 45
(5) Amendment of Short Plat	\$ 25
(6) Environmental Checklist	\$ 90
(7) Amendment of the Comprehensive Land Use Plan	\$300
(8) Shoreline Application:	
(a) Substantial Development	\$110
(b) Conditional Use	\$110
(c) Variance	\$ 65
(d) Revision to Permit	\$ 65
(9) Current Use Assessment	\$ 55 30 <i>JA</i>
(10) Environmental Impact Statement Review, where Clallam County is the Lead Agency	\$250

C.C.C. 3.20.030 Repeal of Prior Fees. The fees set in this ordinance supersede any prior fees set by ordinance or resolution for the administrative services covered herein.

C.C.C. 3.20.040 Severability. If any fee in this ordinance is held invalid by a court of competent jurisdiction, the remaining fees shall remain valid.

C.C.C. 3.20.050 Effective Date. This ordinance shall take effect on Jan. 1, 1980 and shall apply to applications submitted on or after Jan. 1, 1980.
