While reviewing ordinances relating to personnel matters, I came across Ordinance 67, 1976. This ordinance prohibits the County's employing a person while they are receiving retirement benefits.

The County currently has an employee, "Buck" Buchanan, who is working seven hours per week in Clallam Bay. Buck works at the waste disposal site and assists at the treatment plant. He is familiar with all of this work and is of great benefit to the county as his effort and reliability is far beyond what the job calls for. It is especially difficult to find someone in Clallam Bay with the technical background to work at the treatment plant.

Ordinance 67, 1976 would require the County to discharge Buck. I have called Mr. Dion Fisher, Assistant Director of the Department of Retirement Systems concerning any retirement payment problems which might occur by Buck working for the County now. The State has no objection or problem with persons receiving retirement benefits and going back to work for an employer, as long as the hours remain under 70 per month. Buck's retirement income from the State would not be in detriment.

I feel Ordinance 67, 1976 should be amended to allow a retired employee to work for the County on a part-time basis, not to exceed 70 hours per month. The present ordinance ties our hands in being able to use the extensive knowledge and abilities of those persons who are "retired" from County service. The County is benefiting from past experience, thus reducing training costs, and the employees generally are high producers because of their enjoyment in remaining active in the work force.

With this in mind, I have re-drafted Ordinance 67, 1976 for Board consideration and approval.
