ORDINANCE NO. 178, 1983

An ordinance amending C.C.C. 23.04 to change the fees for Overnight Camping:

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

Section 1. C.C.C. 23.04.030 shall be amended as follows:

C.C.C. 23.04.030 Fees: Overnight Camping.

(1) Dungeness, Salt Creek & Pillar Point	\$3.50 per campsite	\$5.00 per campsite	\$3.00 per campsite	\$.50 per person

Off season permit for Pillar Point shall be \$10.00 per year (Jan.1-May 13, Sept.15-Dec.31). This permit does not include use during posted camping season. During the posted season campers must pay daily camp fees shown above.

Camp David Junior

Fees for Camp David Junior shall be based on facilities used with minimum charges based on rated capacities.

(a) Charges for overnight use by large groups (21-101 campers) shall include use of main kitchen, dining hall and lodge and shall be as follows, provided that an additional \$1.00 per cabin per day shall be charged during winter (~~Nov. 1~~)(Oct. 1 - April 30):
