An ordinance amending C.C.C. 23.04.030 to change the fees for overnight camping.

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

Fees for Camp David Junior shall be based on facilities used with minimum charges based on rated capacities.
