Be It Ordained By The Board of Clallam County Commissioners:

## Chapter 3.12

## Purchasing, Contracts and Bonds

- (1) Amend Section C.C.C. 3.12.070(1) to read as follows:
  - (1) The Purchasing Agent shall prepare and the County Commissioners shall approve by resolution and may amend, a list of supplies and contractual services which purchase shall only be made pursuant to the terms of this section.
- (2) Add a new C.C.C. 3.12.080 to read as follows:
  - C.C.C. 3.12.080. Multi-year Contracts Authorized. Contracts for those supplies and contractual services identified by Commissioners resolution pursuant to C.C.C. 3.12.070(1) may exceed one year in length and require the payment of funds from appropriations of subsequent fiscal years. In no event, however, shall the contracts authorized by this section be for more than three (3) years in length.
