ORDINANCE NO. 252 1985

An ordinance amending park rules and regulations.

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

C.C.C. 23.03

General Park Rules and Regulations

Amend Section 23.03.020 (9) to read as follows:

C.C.C. 23.03.020 DEFINITIONS.

- 9. "Park Land". Any park land under the administration and management of Clallam County, including the following:
 - a. Camp David Jr.
 - b. Dungeness Recreation Area
 - c. Salt Creek (Tongue Point) Recreation Area
 - d. Pillar Point Fishing Camp
 - e. Marlyn Nelson Park at Port Williams
 - f. Freshwater Bay County Park
 - g. Lake Aldwell County Park
 - h. Leyendecker County Park
 - i. Lake Pleasant Community Beach
 - j. Vern Samuelson Trail
 - k. Cline Spit County Park
 - l. Clallam Bay Community Park
 - m. Blyn Acreage
 - n. Deep Creek Acreage

Amend Section 23.03.040 (2) to read as follows:

C.C.C. 23.03.040 CAMPING.

- 2. Temporary occupancy of the same campsite by the same person or persons shall be limited to fifteen (15) days; at the end of the fifteenth day, the person or persons along with their camping vehicle(s) must vacate the ((site)) campground area for a minimum of forty-eight (48) hours.

Amend Section 23.03.040 (8) to read as follows:

C.C.C. 23.03.040 CAMPING.

8. Overnight camping is hereby prohibited at the following Clallam County Parks: Marlyn Nelson Park at Port Williams, Freshwater Bay County Park, Lake Aldwell County Park, Lake Pleasant County Park, Leyendecker County Park, ~~((and))~~ Clallam Bay Community Beach and Cline Spit County Park. Overnight camping is hereby prohibited at Pillar Point County Park except (1) during the posted season when the county employed ranger is on duty to register campers and maintain the campground, and (2) during the off-season after obtaining an Off-Season Special Use Permit and following the rules and regulations pertaining to this permit. (Sold for an annual fee of \$10.00 to county residents only).

Amend Section 23.03.050 (3)(a) to read as follows:

C.C.C. 23.03.050 CLOSURES.

- 3. Park hours for open public use are established as follows:
 - a. The following parks will be closed one hour after sunset until one hour before sunrise:

Marlyn Nelson Park at Port Williams, Freshwater Bay Park, Lake Aldwell Park, Lake Pleasant Community Beach, Leyendecker County Park, ~~((and))~~ Clallam Bay Community Beach, and Cline Spit County Park.

Amend Section 23.03.080 (1) to read as follows:

C.C.C. 23.03.080 EXPLOSIVES AND FIREWORKS

- 1. The use or possession of explosives or any type of fireworks is prohibited except upon written permission of the Park Director.

Amend Section 23.030120 (1) (b) to read as follows:

- b. Horseback riding shall be prohibited on the Dungeness Recreation Area except on trails and areas of the park designated for horses. Horseback riding at the Dungeness Recreation Area shall be prohibited on Wednesdays, Saturdays, Sundays and holidays during the general hunting season.

Amend Section 23.04.030 to read as follows:

C.C.C. 23.04.030 FEES: OVERNIGHT CAMPING.

Fees for Camp David Junior shall be based on facilities used with minimum charges based on rated capacities.

(a) Charges for overnight use by large groups (21-101 campers) shall include use of main kitchen, dining hall and lodge and shall be as follows, provided that additional \$1.00 per cabin per day shall be charged during winter (Oct.1-Apr.30):
