ORDINANCE NO. 281, 1986

An Ordinance Amending Park Rules, Regulations and Fees

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

C.C.C. 23.03

General Park Rules and Regulations

Amend Section 23.04.030 to read as follows:

C.C.C. 23.04.030 Fees: Overnight Camping.

<u>Recreation Area</u>	<u>County Residents</u>	<u>Non-County Residents</u>	<u>Group Camping</u>	<u>Non-Profit Organizations</u>
(1) Dungeness, Salt Creek	\$4.00 per campsite	\$6.00 per campsite	\$4.00 per vehicle	\$.65 per person
(2) Pillar Point	\$4.00 ((3-50)) per campsite	\$6.00 ((5-00)) per campsite	\$4.00 per vehicle	\$.65 per person

(2) A second campsite fee shall be charged when the Park Manager allows a second vehicle to be parked in a campsite overnight.

(3) Camp David Junior

Fees for Camp David Junior shall be based on facilities used with minimum charges based on rated capacities.

(a) Charges for overnight use by large groups (21-~~100~~((~~10+~~))campers) shall include use of main kitchen, dining hall and lodge and shall be as follows, provided that an additional \$1.00 per cabin per day shall be charged during winter (Oct.1-Apr.30):

(b) Charges for overnight use by small groups and families (1-20 campers) shall be as follows, provided that an additional \$1.00 per cabin per day shall be charged during winter (Oct.1-Apr.30):

(c) Charges for day use shall be as follows:

One policy manual per organization will be provided free; additional copies are available for 25¢/copy.

Firewood Fee will be \$5.00 per day for each use of Log Cabin fires, Lodge fires, and outdoor fires unless users bring and burn their own wood.

This ordinance shall take effect ten days after adoption.
