

1 NOTICE OF TIME AND PLACE OF HEARING A
2 PROPOSED ORDINANCE

3 WHEREAS, the Board of County Commissioners of Clallam County
4 has been informed that the inhalation of sundry chemical sub-
5 stances and/or compounds has been a serious social problem, and
6 efforts consequently should be made in an attempt to eradicate such
7 evils, therefore, said Board in regular session assembled has
8 considered a proposed ordinance in words and figures following,
9 to-wit:

10 ORDINANCE NO. 29, 1969

11 AN ORDINANCE of Clallam County, State of Washington,
12 relating to solvent inhalation; declar-
13 ing the violation thereof to be a
14 misdemeanor and providing penalties.

15 The Board of County Commissioners for Clallam County, State
16 of Washington, do hereby ordain as follows:

17 Section 1. It shall be unlawful for any person to smell or
18 inhale, for the purpose of becoming intoxicated, inebriated,
19 excited, or stupefied, the fumes from any glue, cement, or any
20 other adhesive containing one or more of the following chemical
21 compounds: acetone, acetate benzine, butyl alcohol, ethyl
22 alcohol, anthylene, dicloride, isopropyl alcohol, methyl ethyl
23 ketone, pentacholorophanol, petroleum ether or toluene.

24 Section 2. That any probative evidence relevant, competent
25 and material offered at a trial for the violation of this ordinance
26 shall be deemed and considered prima facie of intent upon the
27 part of the accused to induce intoxication, inebriation, excite-
28 ment or stupefaction,

29 PROVIDED HOWEVER, that this ordinance shall never be construed
30 as prohibitive of the inhalation of any anesthetic for medical or
31 dental purposes.

32 Section 3. Any person violating any of the provisions of
this ordinance shall be guilty of a misdemeanor and upon conviction
thereof, shall be punished by a fine of not more than \$500.00 or by

1 imprisonment in the County Jail for not more than six months.

2 ADOPTED this 28th day of February, 1969.

3 NOW, THEREFORE,

4 NOTICE IS HEREBY GIVEN that on Friday, the 14th day of March,
5 1969, at the hour of ten o'clock in the forenoon of said day in
6 the Commissioners' Room of the Clallam County Courthouse, Port
7 Angeles, Washington, a public hearing will be held, whereat any
8 person may appear and be heard either for or against the adoption
9 of the foregoing proposed County Ordinance.
