ORDINANCE NO. 336, 1989

AN ORDINANCE AMENDING PARK FEES

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

CHAPTER 23.04

FEE SCHEDULES

Amend Section 23.04.030 to read as follows:

G.C.C. 23.04.030 FEES: OVERNIGHT CAMPING

(1)a. Dungeness (off season)	\$5.00( <del>(\$4.00)</del> ) per campsite	\$7.00( <del>(\$6.00)</del> ) per campsite	\$1.00( <del>(\$-.65)</del> ) per person
b. Dungeness (peak season)	\$6.00 per campsite	\$8.00 per campsite	These rates apply at Dungeness from July 1-Labor Day
c. Pillar Point	\$5.00( <del>(\$4.00)</del> ) per campsite	\$7.00( <del>(\$6.00)</del> ) per campsite	\$1.00( <del>(\$-.65)</del> ) per person
d. Salt Creek	\$5.00( <del>(\$4.00)</del> ) per campsite	\$7.00( <del>(\$6.00)</del> ) per campsite	\$1.00( <del>(\$-.65)</del> ) per person

Off season permit for Pillar Point shall be \$10.00 per year (Jan.1-May 13), Sept.15-Dec.31). This permit does not include use during posted camping season. During the posted season campers must pay daily camp fees shown above.

- (2) A second campsite fee shall be charged when the Park Manager allows a second vehicle to be parked in a campsite overnight.
- (3) Camp David Jr.

Fees for Camp David Jr. shall be based on facilities used with minimum charges based on rated capacities

- (a) Charges for overnight use by large groups (21-100 campers) shall include use of main kitchen, dining hall and lodge and shall be as follows, provided that an additional \$1.00 per cabin per day shall be charged during winter (Oct.1 - Apr.30).


One policy manual per organization will be provided free; additional copies are available for 50¢/copy.


Firewood Fee will be \$5.00 per day for each use of Log Cabin fires, Lodge fires, and outdoor fires unless users bring and burn their own wood.
