AN ORDINANCE AMENDING PARK FEES

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

CHAPTER 23.04

FEE SCHEDULES

Amend Section 23.04.030 to read as follows:

Off season permit for Pillar Point shall be \$10.00 per year (Jan.1-May 13), Sept.15-Dec.31). This permit does not include use during posted camping season. During the posted season campers must pay daily camp fees shown above.

- (2) A second campsite fee shall be charged when the Park Manager allows a second vehicle to be parked in a campsite overnight.
- (3) Camp David Jr.

Fees for Camp David Jr. shall be based on facilities used with minimum charges based on rated capacities $\,$

(a) Charges for overnight use by large groups (21-100 campers) shall include use of main kitchen, dining hall and lodge and shall be as follows, provided that an additional \$1.00 per cabin per day shall be charged during winter (Oct.1 - Apr.30).

Firewood Fee will be \$5.00 per day for each use of Log Cabin fires, Lodge fires, and outdoor fires unless users bring and burn their own wood.

This ordinance shall take effect ten days after adoption.
