ORDINANCE # 348, 1989

An ordinance amending Chapter 3.30, amending the fee schedule for Building Division, Department of Community Development.

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

Section 1. C.C.C. 3.30 shall be amended as follows:

C.C.C. 3.30.030 Fee Schedule for Building Division Services. The following fee schedule is hereby adopted for administrative and inspection services provided by the Clallam County Building Division of the Department of Community Development.

(1) Construction Permit Fees: All building, mechanical and plumbing permit fees shall be based on value and as set forth in Table 3A of the 1985 Uniform Building Code, as follows, except that the minimum permit fee shall be Thirty Dollars (\$30).

- (2) Mobile Home and Modular Home Installation Permit Fee: The fee for a mobile home or modular home installation shall be ((one)) two hundred dollars (((\$\$100.00))) (\$200.00).
- (3) Renewal Fee: The fee for renewal of a construction permit shall be ten dollars (\$10.00) per year.
- (4) Other Inspections and Fees:
 - Inspection outside of normal business Α. hours (minimum charge - two hours
