ORDINANCE NO. <u>375</u>, 1990

An Ordinance amending General Park Rules & Regulations

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

C.C.C. Chapter 23.03

General Park Rules and Regulations

Amend Section 23.03.020 (9) to read as follows:

C.C.C. 23.03.020. Definitions.

- 9. "Park Land". Any park land under the administration and management of Clallam County, including the following:
 - a. Camp David Jr.
 - b. Dungeness Recreation Area
 - c. Salt Creek (Tongue Point) Recreation Area
 - d. Pillar Point Fishing Camp
 - e. Marlyn Nelson Park at Port Williams
 - f. Freshwater Bay County Park
 - ((g. Lake Aldwell County Park))
 - g. Tyee Baseball Field Park
 - ((h. Leyendecker County Park))
 - ((i)) h. Lake Pleasant Community Beach
 - ((j.)) i. Vern Samuelson Trail
 - ((k:)) <u>j.</u> Cline Spit County Park
 - ((1.)) \underline{k} Clallam Bay Community Park
 - ((m. Blyn Acreage))
 - ((n.)) 1. Deep Creek Acreage
 - m. Panorama Vista Public Access

Amend Section 23.03.040 (8) to read as follows:

C.C.C. 23.03.040. Camping.

8. Overnight camping and parking is hereby prohibited at the following County Parks: Marlyn Nelson Park at Port Williams, Freshwater Bay County Park, ((Lake Aldwell Gounty Park,)) Lake Pleasant County Park, ((Leyendeeker Gounty Park,)) Clallam Bay Community Beach and Cline Spit County Park. Overnight camping is hereby prohibited at Pillar Point County Park except (1) during the posted season when the county employed ranger is on duty to register campers and maintain the campground, and (2) during the off-season after obtaining an Off-Season Special Use Permit and following the rules and regulations pertaining to this permit (sold for an annual fee of \$10.00 to county residents only).

Amend Section 23.03.050 (3) to read as follows:

C.C.C. 23.03.050. Closures.

- 3. Park hours for open public use are established as follows:
 - a. The following parks will be closed one hour after sunset until one hour before sunrise:

 Marlyn Nelson Park at Port Williams, Freshwater Bay Park,

 ((take Aldwell Park,)) Lake Pleasant Community Beach and ballfield, ((teyendecker County Park,)) Clallam Bay Community Beach, ((and)) Cline Spit County Park, and Pillar Point County Park. Use of, or being at these areas during closed hours is hereby prohibited except when engaged in recreational or commercial clamming, crabbing, shellfishing or sports fishing which needs to be engaged in after dark due to the nature of tidal flow and availability of launch ramp access.
 - b. Public use of Salt Creek Recreation Area and Dungeness Recreation Area unless registered to camp shall be the below listed hours:

Use of, or being at these areas outside these designated times is hereby prohibited unless registered to camp.

Amend Section 23.03.170 adding (3) and (4) to read as follows:

C.C.C. 34.04.170. Traffic.

- 3. Chaining, locking, tying, or otherwise connecting a boat, bicycle, motorcycle or other piece of equipment or vehicle to any park structure, bridge, building, post, fence other than a boat dock or a bicycle rack designed specifically for such purpose is hereby prohibited.
- 4. Leaving boat trailers, vehicles or other personal articles in a park area, parking lot, or other park facility other than a designated campsite when properly registered overnight and unattended or abandoning such items for more than 24 hours is hereby prohibited.
- 5. Driving or parking of any motorized vehicle, non-motorized trailer, boat trailer on county owned or managed tidelands or shorelands is prohibited, unless involved in the active process of launching or retrieving a boat launched from a designated county boat launch site, or unless used in performance of specific park maintenance or regulatory work by county staff or contractors.

This ordinance shall take effect ten days after adoption.
