

ORDINANCE NO. 503, 1993

An ordinance amending C.C.C. Chapter 23.03  
General Park Rules and Regulations

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

Amend Section 23.03.020 Definitions:

9. "Park Land". Any park land under the administration and management of Clallam County, including the following:

Add P. Clallam County Fairgrounds

Amend Section 23.03.030 Audio Devices; Creating a Nuisance:

Add: 4. In addition, quiet hours shall be observed in campground parks from 10 p.m. until 8:00 a.m. Loud talking, laughing, playing radios or other musical devices in a manner to be heard outside of the campsite is prohibited. Use of generators during quiet hours is prohibited.

Amend Section 23.03.040 Camping

1. a. The number of vehicles occupying a single campsite at one time shall be limited to one (~~ear~~) vehicle, or camper, or one vehicle pulling a trailer, or one motorhome pulling a vehicle, or 3 (~~six (6)~~) bicycles or three (3) motorcycles. A greater number may be authorized in specific areas when constructed facilities so warrant (~~-~~) , and proper fee paid.

Add 1. c. Boat trailers as part of a camping unit may be parked in campsites only if they fit within appropriate site pads and when approved by the Park Manager; otherwise they must be parked in overflow parking areas designated by Park Managers for this purpose. Vehicles used to pull boats/trailers are considered extra vehicles unless vehicle is a truck/camper unit, a motorhome pulling the trailer, or a camping vehicle pulling the trailer per 1.a. above.

Add 1.d. Persons visiting registered campers shall park in day use parking lots and shall not park vehicles in campsites; and shall vacate the premises according to the park hours set down by ordinance for the specific park.

Amend 8. Overnight camping and parking is hereby prohibited at the following Clallam County Parks: Marlyn Nelson Park at Port Williams, Freshwater Bay County Park, Lake Pleasant County Park, Clallam Bay Community Beach, Panorama Vista County Park, Tyee Baseball Field, and Cline Spit County Park. Overnight camping is hereby prohibited at Pillar Point County Park except 1) during the posted season when the county employed ranger is on duty to register campers and maintain the campground, and 2) during the off-season after obtaining an Off-Season Special Use Permit and following the rules and regulations pertaining to this permit (sold for an annual fee of \$10.00 to county residents only).

Amend Section 23.03.050 Closures:

Amend 3.a. Use of, or being at these areas during closed hours is hereby prohibited except when engaged in recreational or commercial clamming, crabbing, shellfishing, or sports fishing which needs to be engaged in after dark due to the nature of tidal flow and availability of launch ramp access ~~((r))~~ , or registered to camp at Pillar Point.

Amend Section 23.03.070 Dogs, Cats and Other Pets and Livestock

Add 6. Pet owners shall be responsible to clean up all pet waste from all park lands and beaches and place it into waste disposal containers or otherwise remove it from park lands.

Amend Section 23.03.080 Explosives, ~~((and))~~ Fireworks, Model Aircraft

Add 3. Operating remote or cable controlled model aircraft with gas or other types of engines is prohibited from park lands.

Add 4. Operating model rockets from park lands is prohibited.

Amend Section 23.03.090 Firearms and Hunting

Amend 2. No persons shall hunt on or at the Clallam County Park known as Dungeness Recreation Area except on Wednesdays, Saturdays, Sundays and State holidays during hunting season and in compliance with Washington State Department of ~~((Game))~~ Wildlife and Clallam County regulations.

Amend Section 23.03.130 Permits, Special Occasion

Amend 1. Special activities that involve exclusive use of park areas and/or facilities by 50 persons or more are prohibited unless a special occasion permit has been issued by the ~~((Park Director))~~ Park Manager.

Amend 3. Applications for a Special Occasion Permit shall be received by the ~~((Park Director))~~ Park Manager not later than ten (10) days prior to the requested special activity and shall set forth the following: the name of the applicant, the date, time, duration, nature and place of the proposed activity, an estimate of the number of persons expected to attend, and a statement of equipment and facilities to be used in connection therewith.

Amend 4. As a condition of the permit issuance, the ~~((Park Director))~~ Park Manager may require the filing of a bond with satisfactory surety payable to the County Park Department to cover costs such as restoration, rehabilitation and cleanup of the area used, and other costs resulting from the permittees' activity. In lieu of a bond, a permittee may elect to deposit cash equal to the amount of the required bond. A charge may also be required if additional park staff are needed to control the special occasion.

Amend Section 23.03.140 Preservation of Public Property

Add 3.a. Cutting firewood from any park land or beach is prohibited. Removal of beach logs from any park land or beach is prohibited.

Amend Section 23.03.180 Violation; Penalties

Amend 2. Any person, firm or corporation who violates any of the rules or regulations provided for in this chapter shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be fined in any sum not exceeding ~~((two))~~ three hundred fifty dollars, or imprisoned in the county jail not exceeding ninety days, or by both fine and imprisonment, for each violation.

This ordinance shall take effect 10 days after adoption.
