AN ORDINANCE AMENDING AND CORRECTING THE LEGAL DESCRIPTION IN EXHIBIT AA TO CHAPTER 9.03 OF THE CLALLAM COUNTY CODE (C.C.C.), WHICH CHAPTER TRANSFERRED TO DAISHOWA AMERICA CO., L.T.D., A FRANCHISE FOR USE OF COUNTY ROADS; AND AMENDING AND CORRECTING THE LEGAL DESCIPTION IN EXHIBIT A TO CHAPTER 9.37 OF THE CLALLAM COUNTY CODE (C.C.C.), WHICH CHAPTER GRANTED TO DAISHOWA AMERICA CO., L.T.D, A FRANCHISE FOR USE OF COUNTY ROADS.

BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

Amend Exhibit AA to Chapter 9.03 and amend Exhibit A to Chapter 9.37 of the Clallam County Code (C.C.C.) to correct legal description by underlining all new material and placing material deleted within double parentheses and scoring through.

An ordinance correcting the legal description of an existing franchise granted to DAISHOWA AMERICA CO., L.T.D. for use of county roads.

Chapter 9.03

The first indented paragraph of Exhibit AA is amended:

Beginning at the Crown Zellerbach Power Dam in the SW ¼ of the NE ¼, Section 15, Township 30 North, Range 7 W.W.M., in Clallam County, Washington; thence northeasterly along County Road No. 30900, known as the Lower Dam Road and the Power Plant Road, to the quarter corner between Sections 11 and 14, Township 30 North, Range 7 W.W.M, which point is the intersection of the Power Plant Road and County Road No. 93110, known as the Laird Road, thence northerly along the last mentioned road approximately 0.((6))5 miles to the intersection of the Laird Road and Elwha River Road – County Road No. 30000, which point is the end of this description.

Laird Road and Edgewood Drive County Road No. 93110 in Clallam County, Washington

Beginning on Laird Road, County Road No. 93110 at the center of Section 11, Township 30 North, Range 7 West W.M., in Clallam County, Washington; thence northerly along Laird Road, County Road No. 93110, to the Northerly terminus of Laird Road and the Westerly terminus of Edgewood Drive, County Road No. 93110 at the approximate sixteenth corner between the Northeast and Northwest Quarters of said Section 11, thence Easterly along Edgewood Drive, County Road No. 93110 ((approximately 0.5 miles))to the City Limits of Port Angeles((at the intersection of Edgewood Drive and Lower Elwha Road, County Road No. 31310)), which point is the end of this description.
