An ordinance amending Clallam County Code Chapter 11.04, Speed Limits on County Roads, to change limits for Lake Dawn Road and Township Line Road

Section 1. Section .020, Speed limit 20 mph, is amended to read as follows:




Section 2. Section .030, Speed limit 25 mph, is amended to remove Lake Dawn Road.
