An ordinance amending Clallam County Code Chapter 21.01, Building and Construction Code to reflect changes to the International Building Code

#### BE IT ORDAINED BY THE BOARD OF CLALLAM COUNTY COMMISSIONERS:

### Section 1. Section .040, International Building Code, is amended to read as follows:

Appendix C, Agricultural Buildings, Appendix G, Flood-Resistant Construction, and Appendix I, Patio Covers, of the 200912 International Building Code (IBC) are hereby adopted by reference.

Appendix G, Flood-Resistant Construction, also applies to residential development and construction under the 2012 International Residential Code.

## Section 2. Section .050, Uniform Plumbing Code, is amended to read as follows:

Appendix D, Sizing Stormwater Drainage Systems; and Appendix E, Manufactured/Mobile Home and Recreational Vehicle Parks, of the 200912 Uniform Plumbing Code (UPC) as published by the International Association of Plumbing and Mechanical Officials are hereby adopted by reference.

## Section 3. Section .060, International Mechanical Code, is amended to read as follows:

Appendix A, Combustion Air Openings and Chimney Connector Pass-Throughs, of the 200912 International Mechanical Code (IMC) as published by the International Code Council is hereby adopted by reference.

# Section 4. Section .070, International Fire Code, is amended to read as follows:

Appendix E, Hazard Categories, and Appendix F, Hazard Ranking, of the 200912 International Fire Code (IFC) as published by the International Code Council (ICC) are hereby adopted by reference.

#### Section 5. Section .115, Refunds, is amended to read as follows:

Pursuant to Section 109.6 of the IBC and Section R108.5 of the IRC the Building Official will authorize refunds, payable to the original payee, as follows:

- (1) Permit/application inactivity after one year will result in forfeiture of all fees.
- (2) For project withdrawal within one year of date of submission with only data entry, the refund shall be 80 percent.
  - (3) Plan review fees will be forfeited if a plan review was conducted.
- (4) If after a permit is issued and a request to withdraw from the project is received within one year of the date of issuance and no work has been started, the refund shall be 80 percent.
- (5) All other fees paid to other divisions will be refunded at their respective division's discretion.
- (6) A submittal of the calculated fees shall be reviewed and approved by the Building Official prior to dispersal.
