CAMPSITE FEE SCHEDULES

C.C.C. 23.04.010 General Regulation. All vehicles must stay in the designated parking area for overnight camping. Camping will be allowed only in numbered campsites. Only one vehicle per site will be allowed, unless otherwise designated.

C.C.C. 23.04.020 Fees: Overnight Camping.

C.C.C. 23.04.030 Fees: Dump Station. There shall be no charge for use of the dump stations by county residents or by paying campers. Out-of-county residents shall be assessed Two Dollars (\$2.00) for use of the dump stations, each use.

C.C.C. 23.04.040 Fees: Picnicking.

(1) Reservations must be made by giving twenty-four (24) hours minimum advance notice to the park.

(2) A fee shall be charged for picnicking, as follows:

	<u>County Residents</u>	<u>Non-County Residents</u>
(a) Reserve kitchen area	no charge	10.00
(b) Group Picnic areas	no charge	5.00

(3) A Twenty-Five Dollar (\$25.00) cleaning and damage deposit is required for groups of fifty (50) or more. Deposit will be refunded after the park manager has inspected the site and ascertained that it has been returned to a satisfactory condition.

C.C.C. 23.04.050 Effective Date. This chapter shall become effective ten (10) days after ~~enactment~~ *adoption* *may post*
